- **Tampa, Florida, AAHPERD Convention**
  - April 1-3. Dr. Stoll traveled to Tampa for the American Alliance of Health, Physical Education, Recreation and Dance; (AAHPERD) is the largest organization of professionals supporting and assisting all specialties related to achieving a healthy lifestyle. The organization dates to November 27, 1885, when William Gilbert Anderson, two years out of medical school and an instructor of physical training at Adelphi Academy in Brooklyn, invited a group of people who were working in the gymnastic field to come together to discuss their profession. Today AAHPERD serves 25,000 members and has its headquarters in Reston, Virginia.
