Keynote Speaker

Dr. Stoll was invited to be the keynote speaker for the 2014 E.C. Davis Lecture at the Western Society of Kinesiology and Wellness, Reno Nevada, October 8, 2014. E. C. Davis or Elwood Craig Davis was a true pioneer of the profession of physical education. He was the author of the historical text in philosophy of physical education, The Philosophic Process in Physical Education. Davis was a professor at UC Berkeley and was instrumental in professional development of professionals on the west coast. He was concerned that no scholarly organizations existed west of the Rocky Mountains, and thus he was a leading impetus to establishing the earlier organization of WSKW, the Western College Physical Education Society in 1956. The E.C. Davis lecture is limited to established professionals in the field who have made a substantial contribution to the profession. Dr. Stoll's lecture is titled: "Character and Leadership: Musings from a Weathered Athlete."

Dr. Stoll then invited Heather Van Mullem, Ph.D., of Lewis Clark State College to contribute to this same article. Dr. Stoll was actually finishing seven years of coaching at the high school level in 1976 and experienced the period of girls athletics growth in high schools. Dr. Van Mullem is a former coach of girls' sports and an advocate of girls and women in sport. The article is due, November 1.
