Quest serves a broad readership that includes academicians, teachers and administrators by providing a public forum for scholarly and creative thought about the profession.

Dr. Stoll and her 37<sup>th</sup> doctoral student, Marcis Fennell, have collected, analyzed, and sent out data from Fingerlakes Community College for a study that accesses the moral development of collegiate student athletes.
