

I. Proposed Changes/Additions to the *Faculty-Staff Handbook (FSH)*.

- FS-11-011: Dual Career Accommodation
 - Comment: I approve this change to the FSH with a one year period for implementation by Human Resources. In addition, Section B-2 must be applied in a fashion consistent with the policies of the Regents, including Policies II.F.1.b.(5) and II.G.1.b) regarding fixed annual terms of employment. Any commitment to fund a position as set out in Section B-2 shall not be construed as implying a term of employment beyond that allowed by the policies of the Regents.
- FS-11-024: FSH 3520 - F-9: Tenure Extension
 - Comment: I approve this change to the FSH subject to the interpretation necessary to maintain consistency with Regents policies II.G.6.b(2) and II.G.6.d.(4)(b) that the request for extension under FSH 3520 Section F-9.A be by formal written request to the Provost indicating that the extension is requested by reason of childbirth or adoption.
