Discussion: The zero credit allows students to take it without getting credit, which resolves risk management issues with having laboratory research done by students who are not signed up for a course or hired for that role. Aleksandra Hollingshead had questions about billing and John Hiller clarified that the students would not be charged for this if they sign up for the zero-credit option.

Discussion: The students tend to leave STAT 550 after the first lecture, so they have scratched that from the curriculum and replaced it with STAT 436, which was always intended as part of this curriculum. The curriculum is being designed to allow only one of the three programming classes, since once a student has one there is no added benefit to having another.

Discussion: Sanjay Sisodiya asked about whether the department would consider adding MKTG 431 Marketing Analytics as an option on the electives list. There are many students who take the Marketing Analytics program and add on a Statistics minor. Christopher Williams responded that they've traditionally done substitution forms for students who fit this scenario. Christopher Williams also mentioned that they are planning to revisit the minor in the future and add a line about "advisor approved electives" which will allow those classes to count without the Substitution forms. Sanjay Sisodiya suggested that having the classes listed explicitly will make Marketing and other Business students more likely to add a Statistics minor. Christopher Williams is concerned about the list of electives being too long if they include every course they've ever allowed as a substitution so the department opted to leave it as is.

Speaker: Rebecca Frost

Discussion: Rebecca Frost described the policies for how and when courses hit the Dormant and Inactive Course lists – those can be found here. She also described how the lists were publicized, to include three emails to Associate Deans, and email to departmental administrative assistants, and being published on the UCC website. She was lenient this year with removing things from the list if people contacted her, since there are some things that appear strange about the list. The Registrar's Office will trouble-shoot those issues before next year's list is released. Mark Warner mentioned that ANTH 509 is being offered this fall with students enrolled. Jim Connors mentioned that the AGED courses have already been dropped via the UCC process, so they are a moot point. AGED 252 has already been reactivated via the UCC process, so it should be removed from the list.

Speaker: Jim Connors

Discussion: A new faculty member has joined the department and redesigned AGED 350 and 359 to include additional content. AGED 461 is the portfolio course. Some students go to Washington for their student teaching. This course captures the process of them building their portfolios to capture their student teaching experience. Lindsey Brown asked how these changes will increase the overall credits for the degree. Jim Connors thinks it is now back up to about 132 credits, which is where the program was in the past. Lori Baker-Eveleth asked about how much coordination there is with the College of Education. Jim Connors explained that the students have to apply to an actual teaching program in CEHHS through which they do their student teaching, but the major is housed within CALS. Dwaine Hubbard asked about whether the intention on AGED 350 is for students to take it multiple times. Jim Connors replied that yes, he would like an amendment to make it max credits of 6. Sanjay Sisodiya mentioned he had the same question. The committee decided to vote on AGED 359 and AGED 461 while Jim Connors attempted to get a final answer about the repeatability for AGED 350.

Discussion: Lori Baker-Eveleth posed a question about the reduction in credits to the AGLS Core. Amy Kingston clarified that the change was passed previously by this committee. Sanjay Sisodiya explained that he tried to tally up the credit hours and had trouble getting them to add up. Dean Panttaja said that if you add in the unlisted General Education requirements, the total hours would be between 129 and 133 credits. Some of those General Education classes are included in this curriculum (e.g., Math) while others are not (e.g., English). Lori Baker-Eveleth asked about why the total credits required for the degree (128) did not change and whether it needs to match the actual requirements for the degree. Rebecca Frost explained that the university has always used this system and that the number in question just reflects what the department says is the baseline number of credits required to graduate, but it does not always perfectly match the total listed in the degree requirements. Lindsey Brown

mentioned that this can be an issue for athletic eligibility, so the Registrar's Office will look at this policy carefully.

Lindsey Brown mentioned that students would probably appreciate having Fall or Spring listed on every course to help them better plan their schedules. Jim Connors asked if we want to table the FCS courses until a representative is available to answer questions and Sanjay Sisodiya said no, since this is not a make-or-break issue for him. He was just hoping to get clarification. Jim Connors suggested we check the original paperwork to see how it was submitted. Rebecca Frost pulled up that paperwork and there is no mention of semesters.

She drew a comparison to the amount of time a student *should* spend reading each week for a regular lecture class.

The lab was not taught for many years, but there is a new instructor now and it is being taught regularly, so they are comfortable adding it back to the curriculum.

Discussion: Bob Tripepi noted some formatting issues at the top of the curriculum. There is no impact – just a clarification of the formatting. BIOL 154/155 are no longer being taught, but since Biological Sciences never dropped those classes it is necessary to make a curriculum change to remove those classes and add EPPN 154/155 instead. Other courses are being added as potential electives and courses. The past inclusion of STAT 251 was the department's mistake since it is included higher up in the curriculum. That class is being replaced with STAT 431. Bob Tripepi explained the rest of the changes, which are fairly straight forward and are designed to give students options to tailor their degrees.

Lori Baker-Eveleth asked about the recommended preparation (3 credits of college Math) and wondered whether it mattered what level of math preparation a student had. There was nobody here to answer that question.

Discussion: SOIL 556 was already approved and the SOIL 456 changes are similar. Lindsey Brown asked about the rationale for including the enrollment limit on ASM 202 and the meeting location on SOIL 417. Jim Connors replied that ASM 202 is limited by the amount of space available in the JML laboratory. Lindsey Brown asked why that needs to be in the course description. If the department happened to get new equipment or larger facilities, do they really want to go back through the curriculum process to change that? Jim Connors mentioned that enrollment for all of these courses has been limited because of space concerns and the chance of them getting more space is slim to none. Lindsey Brown has the same concern about including the meeting location for SOIL 417. Including these unnecessary pieces of information at the course/curriculum level is unneeded and creates more work for the future if those minor details change.
