Speaker: Jim Connors

Discussion: Jim Connors is working with Ellen Kittell, History department chair. They are considering cross-listing this with a History course but have not yet gotten the department/college votes to do so. Jim would like to see the AGED course passed now and the History course created in the next curriculum cycle. Lindsey Brown reminded the committee about the requirements for cross-listed courses, including the sharing of resources. Jim replied that they have not had a chance yet to work out those details.

methods courses.

Discussion: They are updating the prerequisites to reflect the new requirement to take DAN 101 twice,

among other things.

Discussion: This course was created years ago when they were running a domestic violence clinic in the law school. They have since shut down the clinic, so there is no longer an opportunity for students to participate directly in actual cases. However, the topic is still important. They are updating the description to match what they now offer. Steven Shook asked for clarification about the variable credits. Is that still necessary if it is just a lecture course? David Pimentel explained that they have this designation for a number of their LAW courses. They bring in adjunct faculty to teach the course, so they like to retain flexibility to allow the temporary lecturer to determine how much depth they want to offer. Francesca clarified that, for a given semester, the course is either 2 credits or 3 credits. Students do not have the option to choose their credit hours.

Discussion: This will offer an online option to attract more students who might not be able to attend an

in-person program.

Discussion: Lindsey Brown brought up the issue of credit hours required for this degree. It requires 128, even though there appear to be 14 credits of free electives. Dave Paul tabled the item temporarily until Melanie Meenan from the Dance program was able to join the discussion. Lindsey Brown explained that State Board policy requires undergraduate degrees to be 120 credits unless there are specific reasons

related to accreditation requirements. Dean Panttaja confirmed that policy. Melanie mentioned that historically, the degree has been 128 credits because it's a performance-based degree. They have not updated that because of the performance credit requirements. Jim Connors asked if some of the electives could be eliminated to get the degree down to 120 credits. Melanie said that could be possible, but it would need to go back to the department faculty for approval. Francesca Sammarruca asked what happens if we remain out of compliance with State Board requirements. Dean said he will work with Dance to rethink those credits moving forward. Sanjay Sisodiya asked for another clarification of why it was set at 128. Melanie explained that 1) many of their students double major, and 2) they have to take many performance-based classes and having those extra electives allows them to have a more typical B.A. experience in addition to those performance and technique hours. Melanie explained that the department has considered dropping the requirement to 120 in the past but decided not to do so. They were unaware of the State Board policy so they will revisit the issue in the future. Bert Baumgaertner pointed out that this proposal does not change the total number of credits. He is concerned that if we audit programs for credit hours when they come through with other proposed changes, it will discourage other departments from proposing needed changes to avoid that audit. He suggests we pass the proposed changes and give a heads-up that the credits need review in the future. Jim Connors agreed and reminded the committee that this issue had come up before.

John replied that it will remain in the catalog and be considered a technical elective.
