Items under consideration: Water Resources Credit Change for M.S. and Ph.D.

Discussion: Steven Shook asked about the discrepancy between the 24 required credits mentioned in the proposal description (not including research/thesis credits) and the total 30 required credits. The rest of the graduate programs include research credits and just state the total number of required credits. Amy Kingston said she believes the program's intention is to clarify that even if a student takes more than the minimum 6 credits of research/thesis work, the student still needs 24 credits of coursework. Bert Baumgaertner suggested that we update the proposal to add the phrase "a minimum of" before "30 credits" into the catalog language and then copy/paste that into the CIM form. Sanjay Sisodiya thinks the wording on the CIM form (rather than the actual catalog language) is what is causing confusion. Bronte Sone believes this amendment reflects the intentions of the department, though she cannot officially speak on their behalf. There was no representative present from the department.
