Committee agreed that revising the title to include subtitles, and updating the description to be more broad would be preferred, and to do so it should be committed back to the college.

Elizabeth denoted that students on the 2-year degree path be met at the undergrad level, so there is no overlap at that level, but then in levels 3 and 4 is where the overlap would occur. Lindsey clarified the issue is that the 2-year program and the 3-year program would both graduate with the same degree name, and that would not denote which of the 2 paths they took to get there. If they added "advanced standing emphasis" and "non-advanced standing emphasis", that would allow the same degree to be awarded on both paths, but also allow differentiation of the paths taken. There was continued discussion on how to arrange the program.
