I. Chairperson Steve Shook called the meeting to order at 3:30 pm.

II. Announcements and Communications

Steve Shook asked committee members to have Rolling Deadline documents back to him today.

**Items under consideration:** FN 305

**Discussion:** It was noted by Jerry Long and Steve Shook that some of the language in the course description sounded like a prerequisite. Jerry wondered if it was possibly an expected outcome. Trevor explained that the department wanted to ensure prospective students had some high school biology or chemistry experience prior to taking the course. Lindsey Brown recommended changing course description language to “Recommended preparation – high school biology and chemistry” and leave out the rest of the sentence.

**Discussion:** Steve Shook asked if FS 466 should be joint-listed. Lindsey Brown noted that a grad level lab did not exist, so a joint-list was not appropriate.

**Items under consideration:** ANTH 440, 442, 495

**Discussion:** Lindsey Brown asked what the difference was between ANTH 440/442 and ANTH 451. Traci Craig explained that they are different in their approach as to how they analyze bones and that the courses were very different.

**Outcome:** Approved

**Items under consideration:** ENGL 317, 417, 202

**Discussion:** Lindsey Brown noted that ENGL 317 was a highly subscribed course and that she would like to discuss these changes further with Tara McDonald. Tara was unable to attend this meeting. Stacey Doumit also had concerns with the new title of ENGL 317, Intermediate Technical Writing, as it may not look right on her students' transcripts when they were applying for veterinary school. She suggested calling the course Technical Writing II. Karen had the same concern and also liked the idea of Technical Writing II. They are creating a new BS in technical English and those students would be expected to take the 3 technical writing courses in sequence. However, not everyone taking these courses would need to take them in sequence.

**Items under consideration:** ENGL 320

**Discussion:** Lindsey Brown noted that ED 620 also exists, which is also a course called Grant Writing. Should this have a different title? Karen Thompson suggested changing the title of ENGL 320 to "Grant and Proposal Writing."

**Outcome:** Amended to change the title to Grant and Proposal Writing and approved.

**Items under consideration:** ENGL 418

**Discussion:** Stacey Isenbarger noted that her college had a course with a very similar name and suggested this course be tabled until they could have a look to see if it might be the same course. Karen Thompson noted that their courses were rhetorically based, with a focus on language and images. Stacey mentioned that their course is writing intensive and very similar to ENGL 418. Karen agreed.

**Outcome:** Tabled until Art & Architecture and English could discuss these similar courses.

**Items under consideration:** PHIL 426, 427

**Discussion:** Since the retirement of Bill Lund in 2019 we have not been able to offer POLS 425/PHIL 426, and we have only been able to offer POLS 426/PHIL 427 (this course) once. We propose to drop POLS 425/PHIL 426 and rename POLS 426/PHIL 427 from "History of Political Philosophy II" to "Modern Political Philosophy," as it is confusing to have a class called "History of Political Philosophy II" without there being a "History of Political Philosophy I" course. We also would like to change the confusing associate of POLS 426 with PHIL 427; we would like the number for both course entries to be 427. Some discussion followed about equivalencies and was determined that they would be OK as proposed.

**Discussion:** Lindsey Brown mentioned that an (s) should be added to the title if it was supposed to be subtitleable. Mike McCollough mentioned that the course description looked significantly different than the original one. It was decided that the original description had very little information and the new description was just more descriptive.

**Items under consideration:** BIOL 312

**Discussion:** Lindsey Brown mention that "Recommended" comments should be listed under the course description and not the prerequisites. She also asked if prerequisites BIOL 310/315 was "310 and 315" or "310 or 315". Tanya explained that 315 was just the lab and could be dropped as a perquisite.

**Discussion:** Lindsey Brown noted that the course would be offered every fall in the proposal, yet the rationale in the proposal mentioned the course would be offered every other year.

**Discussion:** Steve Shook noted that the rationale for the proposal mentioned cross-listed ME courses with the same name, but the course wasn't cross-listed in the body of the proposal. There was some debate as to whether these proposals should be tabled until the ME courses are approved. John Shovic explained that the ME courses were still in workflow and that the changes to the CS courses should be approved now and not wait for the ME courses to get through workflow. The committee agreed.

For the same reason, it was recommended that title of ECE 545 be changed from Advanced VSLI Design to Advanced Very Large-Scale Integration Design.

Lindsey Brown suggested "(Alt/yrs)" be removed from the description for ECE 521 since this is no longer required with the new Courseleaf software.
