**Speaker**: Casie Moreland

**Discussion:** This is a certificate created to meet accreditation expectations for Dual Credit instructors. Chemistry will be used as a pilot for this program. Dual Credit instructors have waivers for not meeting

faculty requirements at the University of Idaho.

Gwen Gorzelsky commented that part of what this certificate does is solve a problem where we have had some high school teachers providing Dual Credit instruction without having the proper credentials. This will help them get those credentials. Casie continued that this helps the teachers have some theoretical backgrounds in the subjects they are teaching.

Mike McCollough asked if SBOE is requiring other institutions to abide by the same standards U of I is requiring. Casie replied that we are the only institution offering this certificate. Requirements vary between other institutions in the state. CWI does not require any advanced degree work while ISU requires a master's degree.

Casie mentioned that there are two high school chemistry teachers in the state that don't have bachelor's degrees in chemistry. This program would allow them to get the required background in higher education to allow them to teach Dual Credit courses for U of I. These two teachers will be part of the pilot program.
