

## UNIVERSITY CURRICULUM COMMITTEE

2017-18 Meeting #4, October 9, 2017

It was moved and seconded to approve the minutes from UCC3. The minutes were approved unanimously. Chairperson Law thanked Chairperson pro tempore Rick Stoddart for his service last week.

### **UCC-18-005 College of Agricultural and Life Sciences**

### **UCC-18-010 College of Business and Economics**

The committee reconsidered tabled cross-listings. Registrar Heather Chermak asked why the committee was being asked to add and cross-list courses that the department did not intend to offer. Robert Heinse noted that Economics students would rather have ECON on their transcripts than AGECE. Chairperson Law noted that the committee frequently votes together, but split votes are perfectly acceptable. The committee denied the cross-listing requests.

### **UCC-18-011 Honors Program**

Chairperson Law suggested that the committee consider UCC-18-011 next. The committee approved the changes unanimously.

### **UCC-18-010 College of Business and Economics**

The committee elected to table ACCT 561 in order to seek clarification from the department.

Lori Baker-Eveleth introduced the Business changes. Baker-Eveleth noted that students were not adequately prepared in math, which made Math 160 into a bottleneck and slowed down the program. Chairperson Law noted that Math 143 was also being added to curriculum in the same agenda item.

Liz Brandt asked whether MKTG 422 was intended to be a personnel and HR-related course and Baker-Eveleth affirmed. Brandt noted that she would not have gathered that from the title alone. The committee approved the course changes unanimously, with the exception of ACCT 561.

Taylor Raney noted that in the second "Upper-Division" listing in the electives section of the Business Minor, "Discipline" should appear after "Business." Changes to the Business Minor were approved unanimously.

The committee tabled the International Business Minor in order to seek clarification.

With regard to the Marketing Major, Heinse asked what "tier 1" referred to if there were no other tiers. The committee elected to remove "Tier 1" throughout the Major. The changes were approved.

The committee approved the changes to the General College Requirements for Graduation, with one abstention. Hearing no additional questions, Chairperson Law closed the meeting. UCC will reconvene on Monday, October 16.
